Regulation
1. These Regulations may be cited as the Immigration (Visa) (Amendment) Regulations, 2017 and shall be read as one with the Immigration (Visa) Regulations, 2016, hereinafter referred to as the “principal Regulations”.
 2. The principal Regulation is amended by:
 - (a) adding immediately after Regulation 3 (1) d the following “Multiple Entry Visa”;
 - (b) re-arranging item (a) to (d) as item (a) to (e) respectively.
 3. The principal Regulation is amended by deleting the word “Multiple Entries” appearing in the second line of Regulation.
 4. The principal Regulation is amended by deleting the words “Multiple Entries” appearing in the second line of Regulation.
 5. The principal Regulation is amended by deleting the words “Multiple Entries” appearing in the first and second line of Regulation respectively.
 6. The principal Regulation is amended by adding immediately after Regulation 7 the following new Regulation:

Amendment of Regulation 14

- (a) Multiple Entry Visa may be issued for multiple entries within a period of one year to a person whose nationality requires visa to enter the United Republic for purpose of frequently visiting his business;
 - (b) by renumbering Regulations 8 to 16 as Regulations 9 to 17 respectively.
7. The principal Regulation is amended by:

- (a) deleting the word “and” appearing in the marginal notes and replacing it with comma and thereafter adding the words “and loss of endorsed visa” after the word “expiration”;
- (b) adding new sub-regulation (3) immediately after sub-regulation (2) the following new sub regulation.

(3) when a foreigner loses a passport containing a valid visa, he shall be required to pay respective visa fee.

Amendment of the Second Schedule

8. The Second Schedule to the principal Regulations is amended by deleting the whole schedule and substituting for it with the following:

- (c) re-arranging number 11 to 67 as number 12 to 69 respectively.

- (a) deleting the country “Morocco” appearing in number 14 and re-arranging number 1 to 24 as number 1 to 23 respectively;
- (b) adding immediately after item 23 the following:
 - PERSONS WHO REQUIRE VISA**
 - APPROVAL BY COMMISSIONER**
 - GENERAL**
 - 24 Refugees
 - 25 Stateless person
